## PERMIT APPLICATION FOR STORAGE, REFUSE, OR UTILITY CONTAINER

The following conditions must be met in having a storage container, dumpster, or unhitched utility trailer. Trailers that come and go with the construction crew each day are the exceptions, but they cannot block traffic or garage entries.

- No container shall be put in place prior to receiving approval from the Agents.
- Once this form has been accepted as complete, Agents will respond to the application within 10 days.
- Signatures from your neighbors are required for application consideration.
  - For containers to be placed <u>in front</u> of the property, neighbors to each side and across the street should be consulted regarding the potential inconvenience and their signatures collected.
  - o For containers to be placed <u>in the backyard</u>, neighbors to each side and across the alley should be consulted and their signatures collected.
  - Signatures from neighbors can be pen and paper, or an email acknowledgement can be attached to the form.
  - When there are conflicts, the Agents will work with the homeowner and residents to mediate a compromise.
- Containers can be in place <u>no longer than</u> FOUR (4) WEEKS. **Extensions require a new form** with neighbor signatures.
- PODs and other storage containers must not exceed 8'x15'.
- If placed on the street, the container must be within the confines of the applicant's property lines and not encroaching upon neighbors' frontage.
- After the container is removed or emptied and replaced, please ensure all debris is cleaned away from the street/curb/sidewalk.
- Damage to trees, curbs, streetlights, pavement, or any Ames Place community property will be remedied by Ames Place and charged to the applicant/homeowner.
- The Agents reserve the right to ask for removal of any container at any time in the case of unexpected street, streetlight, or utility maintenance or repair.
